For this agreement, the following course substitutions are being allowed:

- CS 1TC = BCOR 121 + BCOR 1TC. This is acceptable for AGEE 110 requirement.
- MKT 260 = BTEC 104. This is acceptable for the ARE 204 requirement.
- ECN 202 = ECON 201. This is acceptable for ARE 150 requirement.
- BUS 206 = BTEC 212. This is acceptable for the ARE 482 requirement.
- ACC 121 = ACCT 1TC. This is acceptable for the ARE 110 requirement.

*ARE 491's summer internship is one of three options available to complete the Agribusiness Management Capstone requirement. Although it is the most pursued option, students may forgo this summer session and complete the requirement via study abroad or thesis composition. Students are encouraged to work with their advisor to select the option that best suits their academic needs and interests.

Students transferring to West Virginia University with an Associate of Arts or Associate of Science degree will have satisfied the General Education Foundation requirements at WVU. However, this is an Associates of Applied Science. Students will need to work with their faculty advisor to complete all outstanding GEFs.
