

## Professional Licensure Disclosure - Pharmacy Technician

Eastern's online, open enrollment Pharmacy Technician program will prepare students to enter the pharmacy field and to take the Pharmacy Technician Certification Board's PTCB exam. To learn more about PTCB, visit their website at <https://www.ptcb.org/>

PTCB certification is contingent on whether the applicant passes the Certified Pharmacy Technician exam.

Many states, including West Virginia, require that pharmacy technicians trainees and pharmacy technicians register with a state pharmacy board, and PTCB certification is one element of West Virginia's registration requirements. The U.S. Department of Education has implemented regulations (34 CFR 668.43 (a) (5) (v)) which requires Eastern to provide a list of all states/jurisdictions where the institution's curriculum, including applicable workforce programs, meets state educational requirements for professional licensure or certification. Please note that these disclosures are updated annually.

Some states do not require licensure/registration to work as a pharmacy technician, and others require registration, and/or possibly national certification through PTCB's exam. The following list of states and territories indicates where the Eastern's Pharmacy Technician training program and/or successful PTCB certification meets requirements, does not meet requirements, or it has not yet been determined by Eastern if the training meets requirements. This information is for initial Pharmacy Technician registration, not for transferring registration from one state to another.

Students are advised to review the information below and confirm Pharmacy Technician licensing/registration requirements in their home states/territories before enrolling in this or any educational program, as state and territory licensing requirements may have changed since the information in this document was last updated.
