ITEM:	Salary Enhancements
COMMITTEE:	Committee of the Whole
RECOMMENDED RESOLUTION:	Resolved, that the Board select and approve one of four salary enhancement options as presented by President Terrell and Executive Dean Reardon.
BACKGROUND:	Currently, both CTCS and HEPC have engaged in numerous conversations with the Governor's Office of Personnel regarding salary increases for faculty and staff. Given the uncertainty of future budgetary demands, it has been determined that institutions may provide one-time salary enhancements that will not become a part of the recipient's continuing base salary.
	West Virginia state law prohibits one-time compensation increases in a lump sum manner. Subsequently, the amount of any salary enhancement shall be provided over the remaining pay periods in the current fiscal year. Institutions electing to pursue this course of action must submit the appropriate WV-11 document to initiate the increase, and then submit another WV-11 to rescind the increase at the close of the fiscal year, June 30, 2011.
