GOAL 3

Provide access to affordable, comprehensive community college and technical college education in all regions of West Virginia

Department of Education Pell Grants-Amanda Sites: State initiative to identify "Diploma Mills"; students are being required to provide the high schools they are graduating from; the following year, schools in question will be investigated. Eastern will be developing policies and procedures regarding identifying legitimate concerns. Presented an overview of recent Department of Education changes including policy revision and adoption. VA benefits have changed as well – resulting in wait periods.

Early Entrance-Pam Shrader: Pam presented reason for decline in Early Entrance participants in the near future, including course offerings across Eastern's service district.

Transition dropped at Petersburg High School – even when offered for free students are not interested.

Eastern is looking into some creative options to generate interest.

Rob Tissue suggested that we reevaluate our allocation of funds to meet the needs for a different market;

Dixie Bean suggested offering a summer prep-course in English and Math.

Dr. Terrell discussed the "Career Coach" concept.
