e. HKM Award

G. Greenwalt reported that the HKM Award Committee (G. Greenwalt, D. Bean, and C. Hakala) met earlier this month and recommends Joseph Kapp as this year's award recipient. On a Lambert/Helmick motion, Joseph Kapp was approved for the award with all in favor.

3. Guest Speaker:

a. US Senator Joe Manchin (via Skype)

S. Staley welcomed P. Hawse and J. Flanagan to the meeting. Sen. Manchin joined the meeting via Skype at 12:15pm. S. Staley welcomed the Senator, and asked Board of Governors to introduce themselves. Sen. Manchin provided updates on the ACA, the Gorsuch nomination, infrastructure, broadband, Corridor H, the opioid epidemic, and the Miner's Protection Act. J. Flanagan asked about the possibility of the ARC being cut. Sen. Manchin responded that he is opposed to ARC cuts, and that WV is the only state where every county would be negatively impacted. Dr. Terrell indicated that supplies for Eastern's new science labs were purchased through ARC funding. Sen. Manchin asked everyone to speak out against cuts to ARC. Sen. Manchin asked Dr. Terrell about the state of the College. Dr. Terrell responded that new strategies are being implemented to increase enrollment, and Sen. Manchin underscored the importance of the College in the community. Sen. Manchin asked whether Eastern would be interested in hosting a job fair. Dr. Terrell responded in the affirmative, and indicated that he and P. Hawse would work together on the project. The Sykpe call ended at 12:45pm as Sen. Manchin had another meeting to attend.

b. Auditor's Report (via conference call)

Auditors from Suttle and Stalnaker, CPA's, joined the meeting at 12:45pm via conference call to review the Financial Statements of the College for the year ended June 30, 2016. A Powerpoint presentation highlighted findings in the Financial Statements and in the Report to the Governing Board. The auditors reported that all financial matters were in order, and that Eastern received the best opinion possible. The auditors recognized the financial management team of the College, specifically Dr. Terrell and P. Reardon, for their quality work and stewardship. The call ended at 1:05pm.
