# EASTERN WEST VIRGINIA COMMUNITY AND TECHNICAL COLLEGE REGULATION NO. – AR 3.10

TITLE: GENERAL EDUCATION COURSE DESIGNATION REGULATION

Section I: General

- 1.1 Scope: The General Education Course Designation Regulation establishes the criteria and guidelines for the review and approval of courses designated as general education courses. The regulation provides the framework for course designation per general education goals set forth in AR 3.17 General Education Regulation assuring academic consistency and attainment of general education learning outcomes.
- 1.2 Authority: AR 3.17 General Education Regulation, WV Council for Community and Technical College Education and Higher Education Policy Commission, Series 24, "Preparation of Students for College"; The Higher Education Policy Commission Core Coursework Transfer Agreement; American Associate of Community and Technical Colleges, *Position Statement on the Associate Degree*, adopted August 1998; Higher Learning Commission, A Commission of The North Central Association of Colleges and Schools, *Commission Statement on General Education*.

#### Section 2: Rationale

The general education curriculum provides the general core for all associate degrees and certificate programs. The general education curriculum demonstrates the College's commitment to provide appropriate and relevant education to enhance the development of learners as they face societal challenges. General education courses provide a breadth of knowledge useful to all students. The criteria and process described below establish the guidelines for designating general education courses assuring that the general education curriculum supports the college mission and the approved general education goals. (AR 3.17)

#### Section 3: General Education Courses: Selection Criteria

For designation as a general education course, a course must meet the following criteria:

- Support one or more of the general education goals as defined in AR 3.17General Education Regulation.
- Match one of the defined domains (communications, humanities and arts, information science, mathematics, natural science, social science)
- Be listed in college catalog at 100 level or higher

- Provide an overview of subject area and be broad in scope
- Include theoretical foundations of the discipline (often introductory level or survey courses)
- · Provide opportunity to develop critical thinking and problem solving skills
- · Open to all students regardless of major

#### Section 4: General Education Course Designations

General education courses can be designated as: communications, humanities and arts, mathematics, natural science, social sciences, or information sciences (BP 3.6). General education courses will be designated in the College Catalog. Courses offered in the following areas can be considered for designation as general education courses:

- Communication: Courses in composition, speech, or listening; and courses designed to enhance competency in the English language.
- Humanities and Arts:
  - · English: literature, creative writing, history of the language
  - · Drama: dramatic literature, dramatic interpretation of the drama, playwriting
  - Foreign Languages: grammar, reading, composition, history of the language, conversation, literature of the language
  - Music: music history, appreciation
  - · Art: art history, appreciation
  - Philosophy: history of philosophy, logic, schools of philosophy, comparative philosophy
  - Religion: history of religion, comparative religion.
- Information Sciences:
  - Computer and information science
- Mathematics:
  - Algebra, mathematics, pre-calculus, calculus, statistics
- Natural Sciences, Physical Sciences:
  - Biology, zoology, anatomy and physiology, physics, chemistry, geology, geography
- Social Sciences:
  - Psychology, social science, sociology, cultural studies, history, anthropology, political science, economics

#### Section 5: Submission and Approval Process

The current curriculum approval process will be used to review and award general education designations (AR 3.7)

 Curriculum proposals will include the standard curriculum forms (Curriculum Proposal Cover Sheet, Master Course Record Form and sample syllabus)

- The completed General education Criteria Checklist must be appended to the curriculum proposal (Attachment A)
- Course currently listed as general education courses will be grandfathered and subject to review to retain status upon next curriculum submission (Attachment B, sample of listing)
- Approved courses will be published in the College Catalog and schedule
